

NOTIFICATION AND AGREEMENT BY PARENTS OF CHILDREN ATTENDING VCC AT
CHURCH OF THE HOLY COMMUNION CATHEDRAL

After much thought and prayer, we have decided to host our annual Vacation Church Camp for Kindergarten to 12th grade students. This decision was taken after much prayer and evaluating the inevitable trade-offs between offering the important teaching and fellowship amongst our youth, and the obvious danger posed by the Coronavirus. However, ultimately the analysis of this trade-off must be made by you as parents, since the major effects of this decision will be imposed on your family.

In particular, the CDC and other expert guidelines and lock-down orders have all been directed at the fact that everyone must be diligent in trying to avoid the Coronavirus. But even with the strict following of the guidelines, there are still risks involved with the renewed socialization of people. We will have mandatory temperature checks upon arrival for every participant at camp. As our state guidelines have encouraged but not required mask wearing on church campuses, we will leave that decision to the parents. Parents should take note that if they are not comfortable with other youth attending without masks, then they should probably keep their children at home.

Therefore, prior to CHCC allowing your child to attend camp, we will require that you sign this document indicating that you understand that it is your decision to allow your child to attend VCC, and that you will hold CHCC harmless from any Coronavirus related issues experienced by your family and waive any rights to make a claim related to Coronavirus against CHCC.

Thank you for your understanding as we all yearn for the eventual return to normalcy.
